REGISTRATION RULES

To ensure the smooth conduct of Trinity MUN 2026, all participating institutions are requested to adhere to the following guidelines:

- Representation in the United Nations Security Council (UNSC) is compulsory for every delegation.
- Each delegation must comprise a minimum of four (4) delegates and may include up to seven (7) delegates.
- Registration shall only be deemed complete upon the submission of all required information and the successful processing of the registration fee.
- Participating institutions are advised to complete payment within the stipulated deadline to avoid any inconvenience or delay in the registration process.
- Upon confirmation of registration, delegations will be notified and provided with their respective country or personality allocations.

Adherence to these guidelines will contribute to a professional, organized, and enriching conference experience for all participants.



CODE OF CONDUCT

To ensure a professional and respectful conference environment, all delegates are expected to adhere to the following guidelines:

- Delegates must conduct themselves with courtesy and respect towards all participants, Executive Board members, faculty advisors, and organisers.
- Any form of misconduct, including offensive language, inappropriate behavior, or discriminatory remarks, will not be tolerated.
- The use or possession of prohibited substances, including electronic cigarettes and narcotics, is strictly forbidden.
- Delegates must not engage in plagiarism, document replication, or any unfair practices.
- Any damage caused to school property will be treated as a serious violation of conference regulations.
- Decisions made by the Executive Council and conference administration shall be considered final.
- Delegates wishing to leave the school premises during conference hours must obtain prior permission from the administration.
- All participants are expected to adhere to the prescribed dress code, use electronic devices responsibly, and maintain cleanliness throughout the conference.

Failure to comply with these regulations may result in disciplinary action, including disqualification from the conference.
